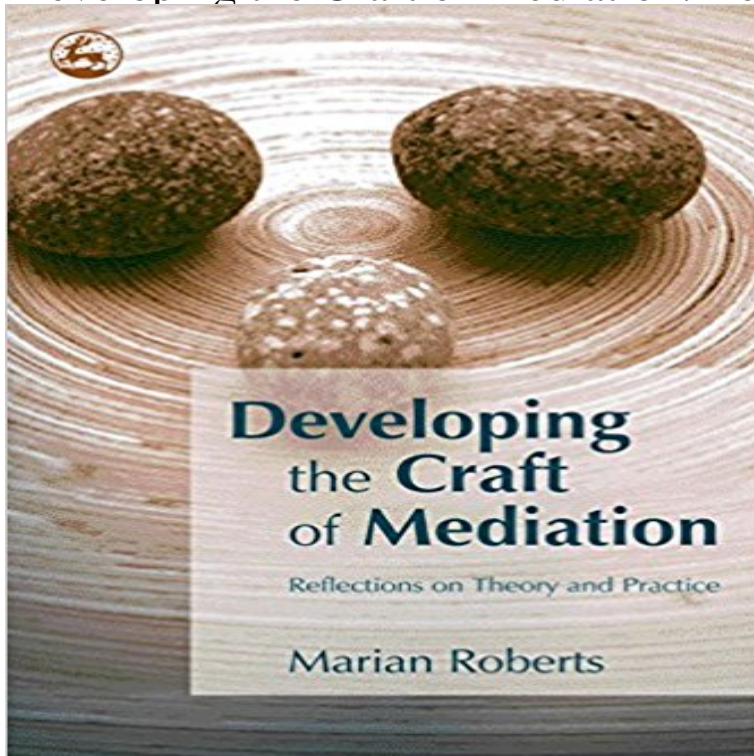


Developing the Craft of Mediation: Reflections on Theory and Practice
