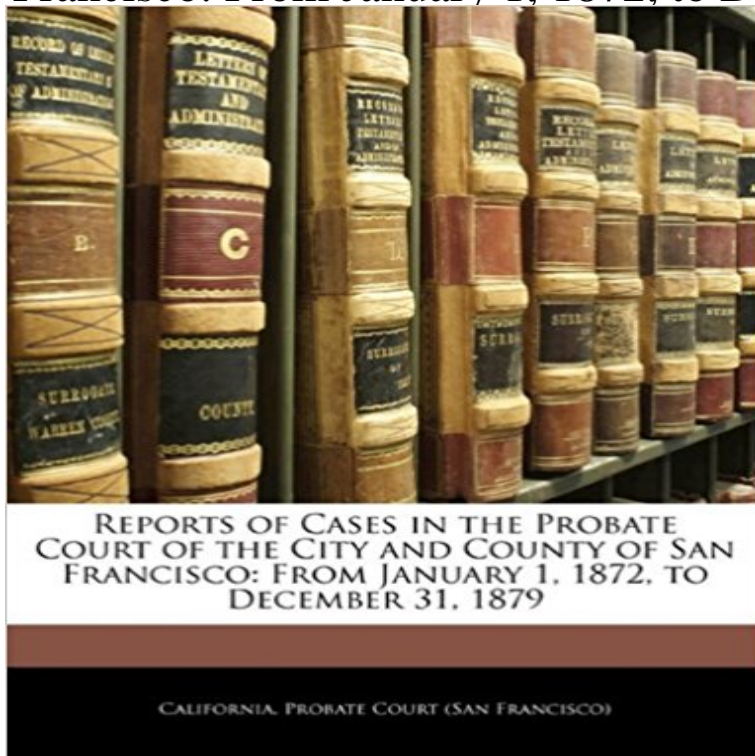


## Reports of Cases in the Probate Court of the City and County of San Francisco: From January 1, 1872, to December 31, 1879
